Mission

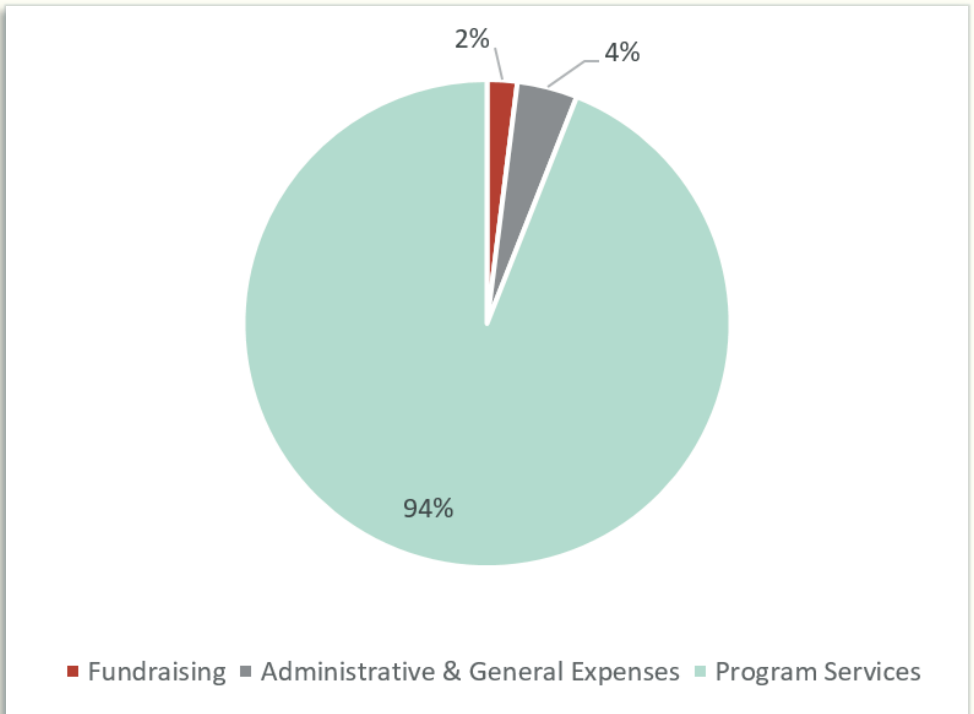
We are inspired by the Gospel to provide free primary healthcare services to uninsured, low-income residents in Northeast Indiana and Northwest Ohio.



Expenses

Our **563 volunteers** donated **27,570 hours** of care and expertise. That donation provides significant savings for operational expenses. Those volunteers, along with our **34 employees**, were able to deliver quality healthcare, as well as hope, to low-income, uninsured adults in North-east Indiana and Northwest Ohio.

During the 2018-2019 fiscal year, we served **25,202 medical** visits and **5,446 dental** visits. Expenses totaled **\$5,980,361**.

45%

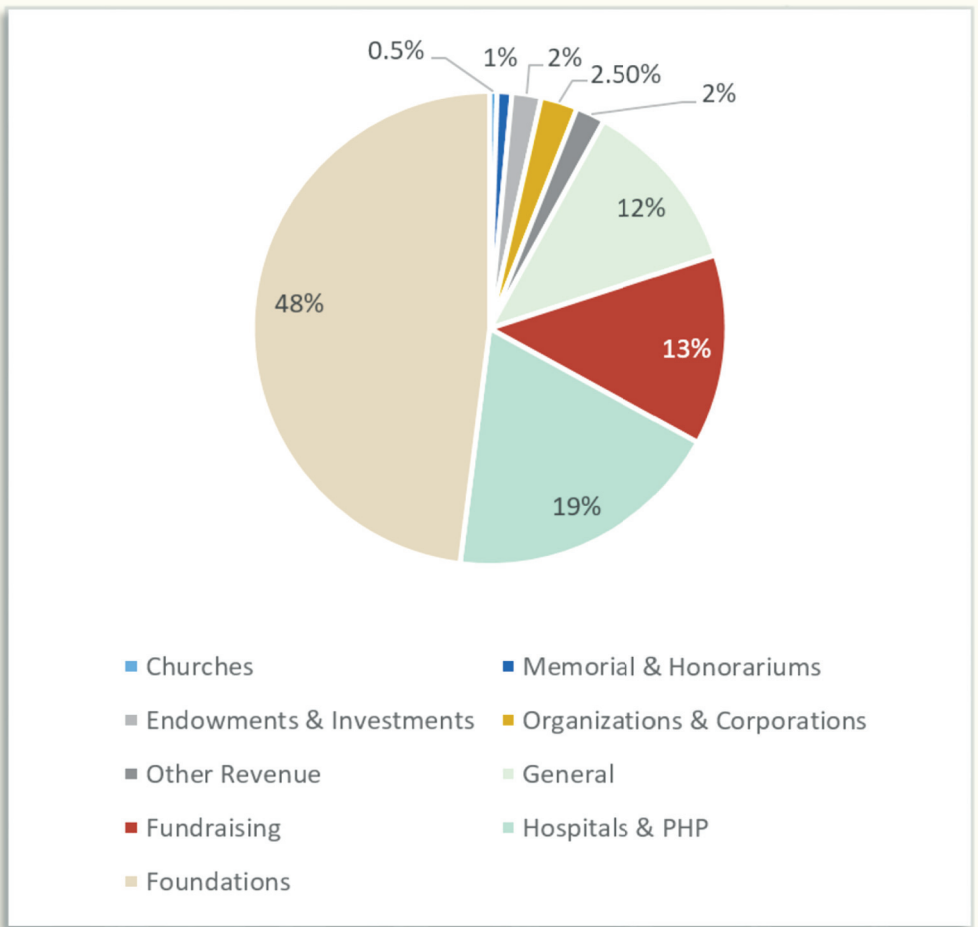

Revenue

We take no government monies nor submit insurance claims. The care our patients receive is dependent entirely on gifts from foundations, corporations and organizations, as well as individuals in our community.

For the 2018-2019 fiscal year, revenue totaled **\$6,327,686** with net assets equaling **\$7,695,144**.
